2009 LICENCE APPLICATION

Please read the notes below before completing your application.

LICENCE TESTING: Licence testing is compulsory for ALL first time senior and junior applicants. This can be completed through your club.

MINI LICENCES: For all junior non competitive licence holders (Replacing Nipper). This can also be used for participants 4 to 15 years of age who are solely competing in Minikhana.

JUNIOR LICENCES: May be issued to rider's ages 7 to 15 years.

SENIOR LICENCES: May be issued to riders who are 16 years or older.

CLUB LICENCE: Used for practice days, Closed to club and Inter club meetings.

NATIONAL LICENCE: Valid for practice days, Club, Interclub and Open meetings.

JUNIOR AND SENIOR RESTRICTED NATIONAL LICENCE: For riders who only competing in Moto Trials, Mini Moto or Fast 50's.

RECREATIONAL: For riders 16 years and over. This licence can not be use for racing.

ENTRANTS: A person or corporate body must have this licence to enter a rider in any competition.

SENIOR AND JUNIOR SPEEDWAY LICENCES: Must be a National licence and have completed the speedway theory and practical test. Only for 9 years and above.

SUPERCROSS: Must have a national licence then pass a Supercross school. The coach must be a level 2 Supercross Coach. Only for 12 Years and above.

JUNIOR ROAD RACE: Riders aged 13 Years and above may have their licences endorsed after being assessed by a MNSW Junior Road Race assessor.

QUADS AND SIDECAR PASSANGER: Quads and Sidecar passenger applicants must complete a further discipline practical and theory test with a MNSW Testing officer.

ONE EVENT NATIONAL: Valid for Historic only. Availability should be in supp reg's.

PHOTOGRAPH: As of the 11th September 2009 MNSW will be issuing licence with **no** photos.

REGISTERED RIDING NUMBERS: Can be registered each calendar year for a fee of \$15.00 per number per discipline.

I authorise any Hospital, Medical Practitioner, Paramedic or First Aid Service to furnish to MA any information relevant to any injury I may suffer during sanctioned activity. I undertake to provide a Medical Clearance to the SCB before participating again if I am hospitalised. I understand it is compulsory for me to have Ambulance Insurance in some form and I accept responsibility for the cost of ambulance transportation.

PRIVACY DECLARATION:

MA and the SCB's require the information requested in this form to provide you with membership services. Your personal information will only be used in accordance with the objects of MA and the SCB, MA and SCB general business and to provide you with membership services.
